Summary

The purpose of the workshop was to provide an opportunity for a range of interested parties to exchange their views about current and planned development activities in this area, and to consider what issues need to be addressed and what mechanisms need to be in place to support a "joined-up approach" to developing the area.

Delegates worked in syndicate groups to:

- Identify a list of current and planned activities taking place in the area.
- Consider what key issues should be taken into account in order to adopt a "joined up" approach to developments in the area.
- Identify the main blocks or barriers that would need to be addressed to support a "joined up approach".
- Recommend mechanisms or actions that would support a "joined up approach."

Each syndicate presented back their views to the main group and then all delegates voted to identify the priority mechanisms that would be required to develop a "joined up" approach to developments in the area.

The feedback from all syndicates revealed some common themes. Overall, delegates indicated a need to have a more integrated approach to developments in the area, primarily because it was felt that the travel links and road infrastructure must take account of the needs of a wide range of interest groups, including those travelling into the area for recreation and leisure pursuits, as well as local residents. There was also considerable debate about the boundaries of the area, what it should be called and how it should be promoted.


