I received paper maps from Rena this morning, one of which shows the one-way sections of the routes. However, I still need an answer to the question of which type of arrow you would prefer us to use to show the one-way system - these were shown on the draft maps that I previously sent to Rena with a request for a decision on the arrow type.

The other thing that has not been answered is the question of the colours that are to be shown for each route - do each of the routes have a different colour of marker on the ground, or are you wanting them shown with the 'grade' colour (Green - easy, Blue - moderate, Red - difficult, Black - severe). If we are to use the grading system, you will need to tell me the grades for each of the three routes.
